### Step3.お金を入金する Make the deposit

送金依頼、またはEZ(イージー)送金口座を開設した後、受取人の口座へ入金するだけで送金できます。

After placing the request or creating the Easy Transfer account, you only need to deposit the amount you wish to send to the recipient.

#### ■スタンダード送金 Deposit method for Standard Transfers

スタンダード送金は送金毎に受取人さま情報の入力が必要になります。みずほ銀行でのみご利用いただけます。

The deposit for Standard Transfers must be made into the Mizuho Bank account you receive after registering for the service

#### ■EZ(イージー)送金 Deposit method for Easy Transfers

EZ (イージー) 送金口座は、みずほ銀行とゆうちょ銀行の二つの銀行から選択でき、5 つまで登録することができます。

There are two deposit methods for the Easy Transfer accounts, which can be selected when registering each account (you can register up to five accounts).
